Terms & Conditions and Cancellation Policy

1. All services are offered on an as-is basis.
2. All fees must be paid in advance. Bank transfer charges are to be met by the senders. A full refund will be given if notice of cancellation is received by 31st May 2015.
3. A refund of 75% of the fee will be given if cancellation is requested after 31st May 2015.
4. We regret that we are unable to refund after 15th July 2015.
5. A cancellation administration charge of £50 will be applied.
6. In the unlikely event of the change of the Conference dates for any reasons beyond our control, should a sponsor/exhibitor wish to withdraw from the Conference, the maximum liability to us shall be limited to 75% of the fees received by us at the time of booking, with no additional liability whatsoever to the Conference Operator (Marques Engineering Ltd), or any individuals affiliated with the Conference in any capacity. We may deduct any additional bank transfer fees associated with the refund.
7. In the unlikely event of cancellation of the Conference, the maximum liability shall be limited to full refund of the fees received by us at the time of booking, with no additional liability whatsoever to the Conference Organisers and host, IAEC or any individuals affiliated with the IAEC in any capacity. We may also deduct any additional bank transfer fees associated with the refund.
8. Should the Conference receive an insufficient number of registrations, the Conference Organizing Committee may cancel the Conference. In this case, the maximum liability of IAEC is limited to a refund of the Sponsorship/Exhibition fee with no additional liability for travel costs, hotel costs, or any other costs or expenses whatsoever.
9. If the cancellation of the Conference is caused by a natural disaster, a disease epidemic or pandemic, war or act of terrorism, the maximum liability to us shall be limited to the full fees received by us at the time of booking, with no additional liability whatsoever to the Conference Organisers, IAEC or any individuals affiliated with the IAEC in any capacity. We may deduct any additional bank transfer fees associated with the refund.
10. Should there be a change in the Conference venue for any reasons, for example to accommodate the participant numbers, all participants, sponsors and exhibitors will be notified well in advance. However, there shall be no liability whatsoever to the Conference Organisers, IAEC or any individuals affiliated with the IAEC in any capacity.
